Site Address: Land South West Of Charlbury Road Hailey

Description of Development: Outline residential development with means of vehicular access from Charlbury Road for consideration, all other matters (layout, appearance, scale and landscaping) reserved for subsequent approval, for the construction of up to 50 dwellings (C3 use), of which 40% will be affordable, landscaping, earthworks to facilitate surface water drainage and all other ancillary infrastructure and enabling works.
